5. Action on Revisions to the Bicycle Mobility Advisory Committee Bylaws

Purpose

The purpose of this agenda item is to take action on revisions to the Bicycle Mobility Advisory Committee's (BMAC) bylaws.

Issue

At their September 2016 meeting, BMAC members expressed an interest in revising BMAC's bylaws to clarify language related to alternate citizen representatives.

At the November 9, 2016 BMAC meeting, MPO staff recommended, and BMAC unanimously approved the language shown below; the underlined text is that which is proposed to be added to the bylaws:

 Agencies, citizens and organizations are encouraged to appoint an alternate member (except when otherwise described above) to serve in case of an absence. Alternates have full "voting membership" privileges when acting as the primary agency representative. <u>Should a citizen representative decline to appoint an alternate member, the BMAC shall select an alternate from applicants to represent bicycling interests at-large.</u>

In accordance with MPO policy, changes to the BMAC by-laws require concurrence of the Technical Advisory Committee (will occur December 2, 2016) and the Transportation Policy Board. The proposed BMAC bylaws in their entirety are attached.

Alamo Area Metropolitan Planning Organization Bicycle Mobility Advisory Committee By-Laws DRAFT October 26, 2015 November 9, 2016

Purpose

The Bicycle Mobility Advisory Committee (BMAC) is established by the Alamo Area Metropolitan Planning Organization (MPO) to improve bicycle mobility within the Alamo Area MPO Study Area.

Generally, the BMAC will:

- Provide bold and visionary leadership in all matters affecting bicycle mobility in the MPO study area
- · Be expansive in its vision and assertive with its mission throughout the entire community

In particular, the BMAC will:

- Consider all technical and public outreach issues related to bicycle mobility including but not limited to urban design, construction standards, design standards, maintenance, access, connectivity and safety.
- Communicate with and educate the public and elected officials on the importance of bicycling through a speaker's bureau as well as periodic articles and opinion pieces to appropriate agency and mass media.
- · Participate in all regional transportation planning activities
- Explore and recommend funding options and opportunities for bicycle-related projects
- Participate in the promotion and implementation of the Regional Bicycle Master Plan and Walkable Community Program as well as other related initiatives
- Promote and participate in annual Walk & Roll activities year round
- Recommend bicycle-related planning studies to be conducted
- · Serve as liaison to other stakeholders and interest groups for bicycling
- Communicate and educate both cyclists and motorists that cyclists have the same rights and responsibilities as motor vehicles on the road
- Advise the MPO's Technical Advisory Committee (TAC) and Transportation Policy Board (TPB) on bicycle-related technical and policy issues. Items on which TAC and the BMAC take different actions may still be brought to the TPB for consideration.

Membership

The BMAC shall consist of a maximum of 25 voting members and a Chair who will vote only in case of a tie. These members define the "voting membership" of the BMAC and shall be appointed in writing by the respective agencies or from nominees.

- One member shall be appointed from each of the following public agency staffs:
 - a) Alamo Area Council of Governments,
 - b) Bexar County Public Works,
 - c) City of Boerne,
 - d) City of New Braunfels,
 - e) City of San Antonio Sustainable Transportation Manager,
 - f) City of San Antonio Transportation & Capital Improvements,
 - g) City of San Antonio Parks and Greenways,
 - h) City of Seguin,
 - i) San Antonio River Authority,
 - j) Texas Department of Transportation San Antonio District, and
 - k) VIA Metropolitan Transit
- Three citizen members shall be selected from applicants to represent bicycling interests at-large. These members shall reside within the MPO study area and be selected to serve on the BMAC because of their knowledge of and experience with bicycling in the Alamo Area.

An application to fill open citizens-at-large positions will be e-mailed to the MPO's standard mailing list and posted on the MPO's website within one month of a vacancy. A subcommittee of the BMAC will review applications, shortlist and may interview candidates as appropriate, and provide a recommended candidate to the BMAC, which as a whole will select the member.

- One (1) member shall be appointed from a professional organization selected by the BMAC on a rotating basis for a two-year, non-renewable term. The appointee should be serving an officer or staff role in a professional organization such as, but not limited to:
 - American Institute of Architects,
 - American Planning Association,
 - Chambers of Commerce,
 - Congress for New Urbanism,
 - Real Estate Council of San Antonio,
 - San Antonio Board of Realtors, or
 - Urban Land Institute

The rotating position is intended to allow different professional organizations to have representation over time on BMAC. After initial appointment the position will be filled by a candidate applying as the alternate member. The alternate will move into the primary position after two years and the vacant alternate position will be posted.

• One (1) member shall be appointed jointly by the Greater Bexar County Council of Cities (GBCCC) and the Northeast Partnership.

- One (1) member shall be appointed by San Antonio Bike Share.
- One (1) member shall be appointed by the San Antonio Wheelmen.
- One (1) member shall be appointed by the South Texas Off-Road Mountain Bikers (STORM).
- One (1) member shall be appointed by BikeTexas
- One (1) member shall be appointed by a cycling organization selected by the BMAC on a rotating basis for a two-year, non-renewable term. The rotating bicycle organization position is intended to allow different community cycling groups to have representation over time on the Bicycle Mobility Advisory Committee. The position will be filled by a candidate applying as the alternate member. The alternate will move into the primary position after two years and the vacant alternate position will be posted.

Agencies, citizens and organizations are encouraged to appoint an alternate member (except when otherwise described above) to serve in case of an absence. Alternates have full "voting membership" privileges when acting as the primary agency representative. Should a citizen representative decline to appoint an alternate member, the BMAC shall select an alternate from applicants to represent bicycling interests at-large.

The BMAC Chair shall be nominated by the BMAC and will be appointed by the MPO Transportation Policy Board for a two-year term.

The BMAC Vice-Chair shall be a member elected by the BMAC membership.

In order to allow for increased citizen participation, the following terms shall apply:

- Agency staff no term limit
- Citizens-at-Large renewable two-year term as approved by BMAC
- Greater Bexar County Council of Cities/Northeast Partnership renewable two-year term as approved by BMAC
- San Antonio Wheelmen, STORM and BikeTexas renewable two-year term as approved by BMAC
- Should a member fail to attend three consecutive meetings of the BMAC, the Chair may recommend that the member be removed and replaced by an alternate or by selecting a representative from previously submitted applications.
- In addition to appointing the voting membership, the BMAC may appoint ex-officio members as appropriate. The ex-officio members are not voting members but will receive all meeting materials and are encouraged to actively participate in all BMAC discussions.

Procedures

- The BMAC shall meet regularly, or as often as necessary.
- The BMAC may meet jointly with the Pedestrian Mobility Advisory Committee (PMAC) as needed.
- BMAC meeting notices and information will be provided by mail or e-mail to all members approximately one week prior to a meeting.
- Meeting minutes shall be made of each meeting. Meeting minutes will be posted on the MPO's website following approval.
- Each agenda will include a "Citizens to Be Heard" item. Participation by interested citizens is encouraged.
- A meeting quorum shall be defined as a majority of the existing voting membership. Vacancies do not count against a quorum. A quorum will be present for all actions taken by the BMAC. The option for members to attend remotely shall be approved by the Chair.
- These by-laws and any future amendments will be approved by the Alamo Area MPO's Technical Advisory Committee.
- Additionally, BMAC will designate a representative and alternate to serve on the voting membership of the TAC. Designation shall be recorded in BMAC's meeting minutes to be officially recognized by the MPO.
- In accordance with Article VII Advisory Committees of the Transportation Policy Board By-Laws for the Alamo Area Metropolitan Planning Organization, all meetings of the Bicycle Mobility Advisory Committee and subcommittees, which may be created, are required to comply with the requirements of the Texas Open Meetings Act.

Staff Support

- Support shall be provided to the BMAC by MPO staff within limitations imposed by budgetary and personnel considerations.
- In consultation with BMAC members, MPO staff will develop the meeting agenda, meeting package, provide meeting minutes, participate in discussions, and coordinate BMAC activities as appropriate.

6. Action on the MPO's Lease Agreement

Purpose

The purpose of this agenda item is to take action on extending the MPO's lease agreement for 825 South St. Mary's Street, San Antonio, Texas 78205.

Issue

The MPO's current lease agreement for the building located at 825 South St. Mary's Street will expire in July 2017. Staff retained the services of a real estate broker to look for new office space and/or negotiate a lease extension with the current landlord. After looking at all options, MPO staff recommended extending the lease and staying in the current building through July 2022.

At their meeting on November 10, 2016, the MPO's Executive Committee unanimously agreed with the recommendation to extend the current lease agreement.

Action Requested

A motion to approve the extension to the lease agreement through July 2022.

7. Presentation on Air Quality: Transportation/General Conformity

Purpose

The purpose of this agenda item is to receive a presentation from TxDOT/TTI on the differences between transportation conformity and general conformity.

Issue

The AAMPO is in the process of preparing for a possible non-attainment for ozone designation next year. TxDOT and TTI have been instrumental in helping the region plan for this eventuality.

At the August Transportation Policy Board meeting, TxDOT/TTI presented "Transportation Conformity for Elected Officials"; in September, TxDOT/TTI presented "Congestion Mitigation for Air Quality: Timing and Benefits".

This presentation by TxDOT/TTI on Transportation/General Conformity was also presented to TAC at their meeting on December 2, 2016.

Action Requested

8. Discussion and Appropriate Action on TxDOT's Unified Transportation Program

Purpose

The purpose of this agenda item is to receive an update from TxDOT staff on the development of the Unified Transportation Program.

Issue

The Texas Transportation Commission is scheduled to take action on the Unified Transportation Program (UTP, TxDOT's 10-year plan) in February 2017. This UTP will include new funding allocations associated with Proposition 1, Proposition 7, and new federal funding levels associated with the FAST Act.

In the coming months, the Transportation Policy Board will be asked to take action on priority projects proposed for inclusion in the UTP. These projects will also need to be added to the Transportation Improvement Program and Metropolitan Transportation Plan. TxDOT will provide this update.

Action Requested

9. Presentation on the Federal and State Freight Planning Requirements, the Freight Workshop Results and Next Steps

Purpose

The purpose of this agenda item is to receive a presentation from MPO staff on the Federal and State freight planning requirements, the November Freight Workshop process, results and next steps.

Issue

At the October 7th TAC meeting, members received briefings on the:

- a. freight provisions in FAST Act
- b. implementation of the Texas Freight Mobility Plan
- c. MPO's process for accomplishing the requirements.

On November 16, the MPO hosted a freight workshop for TAC members. Attendees received presentations on:

- a. MPO Freight Programs in Texas and the United States
- b. results from the November 2013 Freight Stakeholder Workshops
- c. designating a Critical Urban Freight Network

Participants then participated in a mapping exercise to develop a draft Critical Urban Freight Network that could potentially become part of the State's Freight Mobility Plan.

The information from these presentations will be consolidated into a single presentation for your December meeting. MPO staff will present this item.

The MPO has tentatively scheduled freight stakeholder workshops for Wednesday, January 25, 2017 and the MPO's process in support of the statewide freight planning is expected to be complete in April 2017.

Action Requested

10. Discussion and Appropriate Action on Amendments to the Metropolitan Transportation Plan and the FY 2017-2020 Transportation Improvement Program

Purpose

The purpose of this agenda item is to review amendments to the Metropolitan Transportation Plan and the FY 2017-2020 Transportation Improvement Program.

Issue

The Texas Department of Transportation (TxDOT) amends the Statewide Transportation Improvement Program (STIP) on a quarterly basis. To meet our local process for amending the Transportation Improvement Program (TIP), amendments will be reviewed in December with action scheduled for January 2017. In order to keep the Metropolitan Transportation Plan (MTP) and TIP consistent, amendments to the TIP will also need to be made to the MTP.

Air Quality and Regional Planning Efforts in the San Antonio-New Braunfels MSA Alamo Area Council of Governments

Ozone Status

2015 Eight-hour Average Ozone National Ambient Air Quality Standard (2015 ozone NAAQS): To attain this standard, the three-year average of the fourth-highest daily maximum eight-hour average ozone concentration measured at each monitor within an area must not exceed 0.070 ppm (parts per million). Equivalently, must not exceed 70 parts per billion, or 70 ppb. The result of the three-year averaging formula is referred to as the design value.

The following tables list the four-highest maximum eight-hour average ozone concentrations in 2016 and the preliminary design values for the region's three regulatory monitors as of the end of the ozone season, October 31, 2016. Numbers in red represent exceedances of the 70 ppb threshold established by the 2015 ozone NAAQS. Because of high ozone values in 2015, the region's three-year average at C58 (Camp Bullis) and C23 (Marshall High School) exceeded the new ozone standard as early as the first week of April. The table below shows that there were five days where exceedances of the 70 ppb ozone standard were reported at any of the regulatory monitors. Ozone values in 2016 had been relatively low most of the year, with the exception of early May where two exceedances were reported at CAMS 23, one in late September at CAMS 59, and two in early October at CAMS 23 and CAMS 58. Each of these exceedances was preceded by the passage of a cool front which brought with it a pronounced wind shift from southerly to northerly and back to southerly after a couple days.



The following graph shows the design value trend from 2000 to 2016. There has been a clear downward trend in design value since 2013. It is important to remember that the 2016 design value is not official until the data is validated.

On October 1, 2016, Governor Greg Abbott submitted the state's recommendation for nonattainment boundaries to the EPA. Bexar County is the only county in the San Antonio – New Braunfels MSA included in this recommendation.

On November 2, the EPA released its proposed ruling regarding nonattainment classifications. If the proposed rule and 2016 preliminary design value both hold, any local counties designated nonattainment will be done so at the Marginal level. If the nonattainment area does not meet the 2015 ozone NAAQS by the 2020 deadline, it will be bumped up to Moderate. The public comment period for this proposed rule ends January 2, 2017.

In early June 2017, the EPA will release its proposed rule on which counties will be designated nonattainment, after which there will be a month-long public comment period. The EPA will finalize its nonattainment designations on October 1, 2017.

Air Quality Planning Projects

AACOG commissioned Steven R. Nivin, LLC to conduct an economic analysis that determines the cost of a nonattainment designation to the San Antonio-New Braunfels region. The study will include the costs to industry for adding or enhancing their emission control equipment, the cost to local governments for planning activities, such as developing conformity determinations, and the cost of implementing additional voluntary control strategies to help bring the area into attainment. The analysis is nearing completion, with the draft report submitted to AACOG on December 1 and final report due December 31. Monthly meetings have been held between the Cost of Nonattainment Subcommittee and the Contractor to discuss monthly progress reports and ensure a more comprehensive economic impact analysis. A similar report completed by CAPCOG in Austin last year estimated the potential cost of non-attainment to the Central Texas economy to be between \$24 and \$41 billion between 2018 and 2046. Annually, the cost is \$0.9 - \$1.4 billion per year.

AACOG commissioned ETC Institute to conduct a public opinion survey of residents' feelings about and support for emission reduction strategies. This survey, conducted during July and August 2016, polled 866 residents across the eight-county MSA, with 50% surveyed in Bexar County and 50% surveyed in the remaining seven counties. Polling methods included email, standard mail, cell phones and landlines. Participants were asked about their level of support of several emissions-reducing strategies, including adding HOV lanes, anti-idling ordinances, the use of renewable energy, and vehicle emissions testing, among others. The final report on this survey was due to AACOG on October 31, 2016.

A Joint Meeting of AACOG's Air Improvement Resources (AIR) Executive Committee and CAPCOG's Clean Air Coalition was held in San Marcos on November 4. A joint resolution between the two committees regarding 2017 legislative priorities was adopted with the following recommendations:

- 1. Support continued funding of the Rider 7 Local Air Quality Planning Program as described in the TCEQ's Legislative Appropriations Request (LAR) for the FY 2018-2019 biennium even if the San Antonio Area is designated as nonattainment by the EPA in 2017;
- Support maximizing the amount of NO_X reductions that can be achieved in the AACOG and CAPCOG regions through the funds collected for TERP through its grant programs;
- 3. Support the extension of the DERI grant program to August 31, 2025;
- 4. Support increased flexibility in the DACM and LIP programs, including (but not limited to) allowing counties to opt into these programs even if they do not have an emissions inspection and maintenance program;
- 5. Support consideration for making the DACM and LIP programs strictly county-based so as to remove them from the state's appropriation process;
- 6. Oppose eliminating the revenue that is being deposited into the Clean Air Fund from motor vehicle safety inspections;
- 7. Support efforts to improve the clarity and effectiveness of statutes related to idling; and
- 8. Encourage legislators representing the AACOG and CAPCOG regions to sponsor and support legislation advancing these positions.

If for any reason that item is not agendized the member may request consideration by the Transportation Policy Board and the Transportation Policy Board may take action to place the item on a future agenda through the following process:

A recurring item will be added to all agendas to allow the inclusion of special or non-routine items on the next Transportation Policy Board meeting agenda. In order to be placed on the next agenda, each proposed item will require a motion for approval, second, and "yes" majority vote of the quorum present.
